## KEYNOTE SPEAKERS

### *Dr Erna Imperatore Blanche*

*Erna Imperatore Blanche, PhD, OTR/L, FAOTA, is an occupational therapist, USC/WPS Instructor, and Associate Professor in the Department of Occupational Science and Occupational Therapy. She is the co-founder and co-owner of Therapy West, a pediatric clinic in Los Angeles, specializing in sensory integration and serving over 400 clients per week. Dr. Blanche received her basic training in occupational therapy at the University of Chile (Santiago, Chile) and later earned her Masters in Special Education at Columbia University. She received a Ph.D. in Occupational Science at USC. She is an expert in pediatric occupational therapy and interventions based on occupational science. She has co-authored several core books in Sensory Integration and has published numerous articles in English and Spanish on the topics of play and wellness and issues in clinical practice. Her research interests are in the areas of play, clinical evaluation of children with developmental disabilities including autism, and the relationship between sensory processing and lifestyle choices. Dr. Blanche has lectured internationally in more than 20 countries.*

### *Dr Diane Parham*

*Diane Parham, PhD, OTR/L, FAOTA, is highly regarded for her work on Sensory Integration and on play as occupation. As a faculty member at the University of Southern California (USC), she became a key organizer of the groundbreaking Ph.D. program in Occupational Science, and more recently, the Doctor of Occupational Therapy (OTD) degree program. She is a founding member of the Sensory Integration Research Collaborative. Her research interests lie primarily in the areas of physiological and behavioral correlates of sensory modulation difficulties, measurement of sensory integrative problems in children, sensory integration and praxis problems in autism, and design of sensory-based interventions in occupational therapy for children. Dr. Parham was the Primary Investigator in a study addressing Outcomes of Sensory-Based Intervention after Birth Trauma, and of a study on Occupational Science-Based Training in Pediatric Occupational Therapy. She is first author of the recently published, norm-based Sensory Processing Measure (SPM), which provides scaled scores on sensory processing, motor planning, and social participation of children aged 5-12 years. Dr. Parham is currently Professor and Director of the Occupational Therapy Program, University of New Mexico*

### *Dr Roseann Schaaf*

*Roseann Schaaf, Ph.D., OTR/L, FAOTA is an occupational therapist, USC/WPS Instructor, and Associate Professor and Vice Chairman in the Department of Occupational Therapy at Thomas Jefferson University in Philadelphia where she teaches neuroscience, pediatrics, leadership and clinical courses. She is co-author of several core books on sensory integration. Dr. Schaaf has a doctorate in neurosciences. Among her primary research interests are physiological measures of sensory processing disorders. Recently she was awarded a grant from Autism Speaks to study the effectiveness of occupational therapy using sensory strategies with children with autism. In addition, Dr. Schaaf stays in touch with clinical practice in her own private practice. She lectures nationally and internationally, and participants benefit greatly from her 30 years of clinical and research experience. Dr. Schaaf is especially recognized for her ability to explain complex concepts in a practical way and to apply research findings to clinical practice.*
